Bureau of Indian Standards

Compulsory Registration Scheme (CRS): Electronics Products

Bureau of Indian Standards (BIS) is the National Standards Body of India. It is established by the Bureau of Indian Standards Act, 1986 which came into effect on 23 december 1986. In 2012, The Department of Electronics and Information Technology (DietY) now called Ministry of Electronics and Information Technology (MeitY) and Bureau of Indian Standards (BIS) hand in hand launched Compulsory Registration scheme (CRS).

WHO CAN APPLY?

This scheme states that it is mandatory for manufacturers to get their products BIS registered before launching them in Indian market. Manufacturers of the 65 products mentioned below are required to apply for grant of Registration under Compulsory Registration Scheme (CRS) after getting their product tested from BIS recognized labs.

PROCESS TIME

Total time for BIS Registration will be approx. 30 working days, including testing time (15 working days) and BIS application processing time (15 working days).



BIS-ISI Mark: Product Certification Scheme

ISI: Foreign Manufacturers Certification Scheme

FMCS is a scheme under which BIS license is granted to a foreign manufacturer in accordance with the BIS Act, 1986 and Regulation 3 and 4 of the BIS (Certification) Regulations, 1987.

WHO CAN APPLY?

The manufacturers, which have their factory location outside India can apply under FMCS. They shall: Ensure conformity of their product(s) to applicable Indian Standard Specifications.

Shall have all manufacturing machineries/facilities at their factory premises.

Shall have all arrangements/equipments in their factory premises for testing of the product(s) as per applicable ISS.

Shall have competent testing personnel in their lab to test the product(s) as per applicable ISS. Must accept the Scheme of Testing & Inspection (STI), Marking Fee and Terms & Conditions of license.

PROCESS TIME

Total time for Certification will be approx. 6 months from the date of submission of Application documents.



















Steps involved for ISI Certification Process

WPC Approvals

WPC: ETA & Import License, Equipment Type Approval

Manufacturers/Importers of products with Bluetooth and Wifi features are required to get the WPC approval and Import license Certificate before to be sold into India Market.

PROCESS TIME (ETA)

Total time for Approvals will be approx. 12~15 days from the date of submission of Application documents.

















TEC Approvals: Type Approvals for Telecom Equipment

TEC: For Telecom Equipment

Mandatory Testing and Certification of Telecom Equipments (MTCTE)

The Indian Telegraph (Amendment) Rules, 2017, provides that every telecom equipment must undergo prior mandatory testing and certification. The detailed procedure for Mandatory Testing and Certification of Telecom Equipments (MTCTE) under these rules shall be notified separately. The testing is to be carried out by Indian Accredited Labs and based upon their test reports, the certificate shall be issued by TEC. A separate portal is being developed for online administration of this procedure.









BEE: Star Rating

The Objectives of Standards & Labeling Program is to provide the consumer an informed choice about the energy saving and thereby the cost saving potential of the marketed household and other equipment. This is expected to impact the energy savings in the medium and long run while at the same time it will position domestic industry to compete in such markets where norms for energy efficiency are mandatory.

Total time for Approvals will be approx. 30~45 days from the date of submission of Application documents.
