- S.O.-----(E).- In exercise of the powers conferred by sub-section (1) and (2) of section 16 read with section 17 and sub-section (3) of section 25 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government, after consulting the Bureau of Indian standards, is of the opinion that it is necessary or expedient so to do in the public interest, hereby makes the following Order, namely:-
- **1. Short title and commencement.** (1) This Order may be called the Rolled Glass (Quality Control) Order, 2025.
- (2) It shall come into force with effect from six months from the date of notification in e-Gazette
- (3) It shall apply to goods or articles specified in Column (1) of the Table below and shall not apply to goods or article meant for export.
- 2. Conformity to standard and compulsory use of Standard Mark Goods or articles specified in column (1) of the said Table shall conform to the corresponding Indian Standard given in column (2) bearing the title of the Indian Standard in Column (3) of the said Table and shall bear the Standard Mark under a licence from the Bureau of Indian Standards as per Scheme-I of Schedule-II of the Bureau of Indian Standards (Conformity Assessment) Regulations, 2018 from the date specified in the corresponding entry under column (4) of the table:

Provided further that the small enterprises and micro enterprises, as defined under the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006) shall conform to such Indian Standards from the date specified in the corresponding entry under columns (5) and (6) of the Table respectively:

- 3. **Certification and Enforcement Authority.** In respect of goods or article specified in Column (1) of said table, the Bureau of Indian Standards shall be the certifying and enforcing authority.
- **4. Penalty for Contravention**. Any person who contravenes the provisions of this Order shall be punishable under the provisions of the Bureau of Indian Standards Act, 2016.
